Dear Secretary LaHood:

On behalf of Governor Jim Doyle, I am pleased to provide you with Wisconsin's certification of airport projects under section 1511 of the American Recovery and Reinvestment Act (ARRA). Seven airport projects in Wisconsin have been selected by the Federal Aviation Administration to receive \$13.3 million in ARRA funding:
