MATTERS OF EMERGENCY/INFORMATIONAL NATURE

Mike Steffes advised that the Capitol Police have asked the Dane County Sheriff's Department to assist them with crowd control. As there are not enough officers available in Madison, the Dane County Sheriff has requested mutual aid from other departments throughout the State. The Oneida County Sheriff's Department is sending two officers, and has asked if the Rhinelander Police Department can also send two officers. Mike noted that at this time, there are no funds available to reimburse us for our expenses. If we sent two officers, they would work on Tuesday at straight time, as regular work days; Wednesday is their scheduled day off, so we would pay 12 hours of overtime for each officer. There may also be lodging expenses. Sonny Paszak asked why the National Guard is not being used for this purpose. The Mayor stated that his stand would be no; the money is one issue, but he also doesn't feel it's appropriate for our officers to go down there. Alex Young noted that there have been a lot of people, but it's been pretty peaceful; if it was a riot or natural disaster situation, it would be different. Tom Gleason stated that he feels we should send the officers to show good faith, in case we need help in the future. Sonny stated that if the Oneida County Sheriff is sending two officers, he feels that's enough. Tom felt we should send at least one officer, just to show that the RPD was represented. Bill Bell agreed with Tom, stating that mutual aid is very important in law enforcement. After further discussion, the Committee directed Chief Steffes to proceed as he feels best.
